

Guarantor’s Commitment & Agreements

Little Hill – Alina Lodge is a nonprofit, long-term residential rehabilitation center for chemically addicted men and women. Over 95% of our funding comes from student guarantors such as yourself. Our primary consideration is that our students receive the extended treatment necessary to enable them to get well and to begin a life of sobriety. Our financial goal is to provide quality treatment at the most affordable fee possible. It is, however, an economic fact-of-life that we obtain timely payment, in full, of all fees billed to guarantors to maintain the financial health of the Lodge.

Guarantor’s Commitment:

As a guarantor, you are committing to pay the student daily treatment rate, currently at \$295 per day for the entire length of stay of the student. *On admission we require a non-refundable deposit equal to 30 days of treatment (\$8,850), plus a deposit for incidental expenses (\$250). The total deposit required is \$9,100.* This deposit will be used to fund the first 30 days of treatment. In addition, all costs and expenses for health care (exclusive of substance abuse treatment at the Lodge) will be billed to student/ guarantor(s) account. The guarantor is also responsible, on an on going basis, for the cost of student incidentals such as toiletries, laundry, off site transportation, stationary items etc.

Although the length of stay varies with each individual, the average stay is between six and nine months. The length of stay depends on the severity of the case and the student’s response to treatment. The cost for treatment at Alina Lodge for a six-month stay exclusive of ancillary charges is \$53,100.00. In addition to this figure, the cost of incidentals and non-substance abuse medical treatment will be added. You, as guarantor of the patient (student) account, will be billed every 2 weeks for the cost of treatment, incidentals and medical expenses. Payment is due within 15 days of receipt of a billing.

Guarantor’s Agreements:

I(we) acknowledge the treatment fees and other costs associated at Little Hill – Alina Lodge as described above. I(we) guarantee to pay in full, within 15 days of receipt of each billing, all the student charges billed. If more than one Guarantor has signed a guarantee for a student, their obligations hereunder shall be joint and several. This is a continuing guarantee, which shall remain and continue in force until all indebtedness of the student/guarantor(s) are fully paid. Little Hill – Alina Lodge reserves the right to change its fees upon reasonable advance written notice. This guarantee contains the full and total understanding of the parties. This guarantee cannot be terminated, modified or changed without the written consent of the Executive Director of Little Hill – Alina Lodge.

All of the above fully understood, agreed to, acknowledged and accepted by the guarantor(s): If the guarantor is married, both husband and wife must sign the guarantor form.
