

LEGACY OPPORTUNITIES

Through the Alina Lodge Legacy Society, benefactors have an opportunity to leave a lasting legacy in the following ways:

- **Bequest of Cash:**
Alina Lodge is named the beneficiary of a specific dollar amount or a percentage of an estate.
- **Bequest of Real Estate, Assets and Tangible Property:**
Alina Lodge is named the beneficiary of assets including real estate, securities, closely held stock, or tangible personal property such as art, jewelry and boats.
- **Residuary Bequest:**
Alina Lodge is named the beneficiary of all or a percentage of the remainder of an estate after the payment of bequests and expenses.
- **Retirement Plan:**
Alina Lodge is named the beneficiary of the remainder of an IRA or a qualified pension or profit-sharing plan.
- **Planned Gifts of Life Insurance:**
Alina Lodge is named the beneficiary of a Life Insurance policy as ownership is transferred to Alina Lodge by the policy holder.
